Item-3: Report by Treasurer

Item-4: Report by Editor

Editor-JIAFM, Dr Mukesh Yadav, presented Editor's report, which was unanimously accepted by the house. Dr V B Sahay proposed to appreciate the efforts made by him and house unanimously appreciated his efforts for timely publication and circulation of publication with reasonably good quality of manuscripts.

Item-5: Sanction of Life memberships (996 onwards)

Since last general body meeting, the office was in receipt of 76 applications for life memberships. The same was placed before the house. The life membership to LM No. 996 to LM No. 1071 were sanctioned by the house and the applicants are conferred life memberships of IAFM.

Item-6: Affiliation- Odhissa Chapter of IAFM

Application by Dr P. Mohanty to affiliate their state association -

- "Medico legal Society of Odhissa" as "Odhissa Chapter of IAFM" in form of specimen resolution sanctioned at GBM held at Jaipur in 2001 was placed before EC on 15-12-2013. The application was considered positively and granted "provisional" affiliation as state chapter subject to compliance of following before next GC meeting (30-01-2014) and subject to sanction by General Body Meeting at Gauhati on 01-02-2013":
 - a) Constitution shall be amended as central IAFM one;
 - b) All official correspondence to any state authority shall be conveyed to central IAFM;
 - c) No official communication to national authority may be made without prior approval of central IAFM;
 - d) One of GC member of central IAFM shall be invited to GBM, GC and conference;
 - e) A token fees for affiliation (may be Rs. 11,000/-) may be deposited to central IAFM;
 - f) Non compliance of any of above or constitution of IAFM will attract refusal for "permanent" affiliation and discontinuation of affiliation subsequently in future.

It was proposed by Dr Madhu Ghodkirekar to approve the proposal and the same was seconded by Dr Sanjoy Das. It was unanimously resolved by the house that "Medico legal Society of Odhissa" may be granted affiliation as "Odhissa Chapter of IAFM".

Item-7: Co-Opting one member form Goa as EC member

In the light of agenda item no.15 resolved at General Body meeting at KMC, Manglore on 02-02-2013 and agenda item no 6 resolved at 1st EC meeting at KMC, Manglore on 03-02-2013and at 2nd EC meeting on 15-12-2013 **proposed by** it was Dr Ninave **to permanently co-opt** an IAFM member from Goa Medical College, Bambolim, Goa as "Co Opted GC member". Dr Nanandkar while exercising his power conferred to his office under s/s (c) of section VII of Chapter-II of the constitution of IAFM expressed his assent for the same and upon sanction by President Dr Ninave proposed the name of Dr Madhu Ghodkirekar as "Co-Opted GC Member" for the Governing council 2013-2016.
