passed and its office job seconded to approve and it was unanimously resolved by the house that "amendments suggested by the house concerning committee composed vide item No 9 of OBM held on 01-02-2019 and vide item No 9 of OBM held on 23-12-2015" approved part-B of Special POM approved. Ahsan subsequently also approved after one month of special item by 9th Executive Committee meeting held on 15.11.2019 are resolved and approved. Incumbent General Secretary shall comply necessary communication to the Inspector General Societies, Punjab, India.

Item No. 3: Editor Jyoti Dr. Mahesh Yadav submitted his report before the house. Mr. V. B. Sahni proposed to appreciate his sincere efforts for regular publication and improving the quality and the house was seconded by Mr. Ashok Shrivastava. House unanimously approved his report and place on record and of appreciations. Expenses incurred and paid were approved.

Item No. 4: Treasurer Mr. SK Bada placed before the house audited report upto 31st December 2018 along with income expenditure statement and balance sheet. Mr. D. S. Budhan proposed to approve which was seconded by Mr. B. P. Dubey.

House was also apprised about notice from Income Tax Department for payment of taxes after filing ITR of IAFM. He also updated the house that in consultation with chartered accountant of IAFM the matter shall be pursued further and also enclosed "appeal" Expenses incurred by treasurer for mounting books of accounts, balance sheet, audited report, filing ITR of IAFM etc are approved. Moreover, house appreciated work done

Item No. 5: General Secretary - Dr. Ashok Jain, expressed since the suggestion of IAFM has been submitted upto 2020. He placed before the house the "substance and guidance for the process of renewal of registration; noteworthy thanks to Dr. Shweta Saxena Sir and Dr. Madhu Choudhary - life members of IAFM for their

(b) With reference to personal regarding "Minimum Standard Requirements" prescribed by Medical Council of India, also Delhi also reference to discipline of "Foreign Medicine including Teaching" need of various reasons (including legal) also placed before house. Upon multiple discussion it was decided unanimously to form a "panel" of IAFM life members who shall decide - draft petition, lawyer/advocate, budget/expenses there upon and any other issue related to legal recourse for betterment of discipline and in the best interest of IAFM. It was unanimously resolved that Governing Council of IAFM (2018-2020) shall have privilege to form such panel and seek remedy - legitimate legal one if required [only in the best interest of discipline and IAFM].

(c) Expenses incurred not exceeding Rs. 10,000/- by Secretary were approved.

(d) It was unanimously resolved that in current year house must ensure transfer of charge to office bearers for 2018-2019 of IAFM; for smooth functioning of IAFM.

Item No. 6 Applications for becoming life members of IAFM were placed before house. The life membership of IAFM were conferred to LM No 1128 and LM No 1146 to 1183.

House unanimously appreciated membership drive resulting in increase of 288 members in last three years.



Item No. 3: resolved that a proposal to amend the constitution of IAFM and organising election to the governing council in order to open to "proposals" by Dr. Ashish Ghoshkar, Dr. Mahesh Yadav and Dr. Harish Patel. However it was unanimously resolved that governing council of IAFM 2016-2019 shall take final decision about the same in consultation with all these proposals.

Additional Item permitted by chair: Dr. S.K. Das proposed permission of chair, presented that:  
 a) Permission of India and Constitution of IAFM are silent upon to multiple interpretation with reference to "in which zone a member belonging to is to say state of becoming life member or place of work".  
 b) For zone distribution of states including Delhi together in North Zone or Central Zone. Upon constitutional submission and arguments he who resolved that Governing Council of IAFM for 2016-2019 shall address both issues in their COBIS scheduled in 2017 and till then existing provisions shall be considered for election of zone bearers for 2016-2019.

Item No. 8: resolved and decided that the committee meeting held at 12.00 Noon on 08.01.2016, Dr. G. Pradeep Kumar was appointed "Election Officer" for election of zone bearers of IAFM for 2016-2019 and General Secretary issued him letter [IAFM/01/2016 dated 08.01.2016]. He accepted the role and executed the duty as "Election Officer".

Upon completing election procedure as per bye laws and conducting with utmost commitment and transparency he declared the results and received the office of election officer.
