

Agenda Item No.5: Report of the Treasure

The treasurer of the IAFM, Dr.C.B. Jani, circulated audited copies of accounts for financial year 2021-2022. (Copies of Audited Accounts by Charter Accountant: D.S.Soni are attached as Annexure). He requested members for any objections, suggested or queries. Since there were no objections, suggestions or queries, the Audited accounts for financial year 2021-22 were adopted with following resolution:

Resolution No. 2: It is resolved to adopt and accept Audited Account report for Financial Year 2021-22 prepared by Chartered Accountant: D.R. Soni.

The treasurer informed members that Rs.40000.00 provided to Editor, for printing of Journal of IAFM and Rs. 20,000/- for the Secretariat expenses. He informed that details of all other expenses are mentioned in the audited reports. Regarding financial assets of IAFM, he informed that a balance at the end of financial year 2021-22 ending on 31.03.2022, was Rs.81,52, 839.00 in the IAFM Account, and by adding Interest incurred on FD it comes to Rs.82,13,423.00. He further informed that Charter Accountant has advised to keep major chunk of the fund, in capital fund of the IAFM, in order to get Income Tax benefit on interest incurred, as IAFM being a non-profit charitable society. He informed that the amount in capital fund can be used only with approval of G.B.M. In this regard, he proposed to open a permanent bank account at Head Office in Goa, to be operated jointly by the Treasurer and Representative Income Tax Assesses for the IAFM. He further proposed to request Dr.Madhu s Ghodkirekar, to be Representative Assesses for IAFM as placed in Head Office. The President Dr P C Vyas asked Dr Madhu Ghodkirekar whether he is ready to accept responsibilities. Dr. Madhu Ghodkirekar, conveyed his willingness with condition that proper accountability be fixed of all concerned persons, through proper AGBM resolution. The Treasurer, informed about need for renewal of IAFM Account for Tax Exemption u/s 12A and 80G, by Next Treasurer and Governing Council for 2022-2025. He also proposed to transfer of JIAFM Funds to Main Account of IAFM at Goa, after opening permanent Bank Account. was also informed. He further, thanked Dr Ashish Jain and Dr S. K. Dadu for providing financial statement of bank on time. An issue was raised Dr Anand from ICRC. Regarding FCR registration, however house agreed that matter will be discussed by next Governing Council. At the end of discussion following two more resolutions were passed.
